Call to Order and Pledge of Allegiance (Time: 6:02pm)

- I. **Roll Call**- All members present, with the exception of Member Harris and Member Engeron.
- II. **Approval of the Agenda**- Agenda approved as presented. Motion made by Member Palscik. Second by Vice Chair Flynn. Vote 3-0, with Member Harris and Member Engeron absent.
