- I. Approval of the Agenda-** Motion to approve made by Member Richman, seconded by Member Hardy; 5-0
- II. Approval of the Minutes of the Regular November 19, 2025 Meeting-** Motion to approve made by Member Lawrence, seconded by Member Hardy; 5-0
- III. Public Comment-** None; The Chair mentioned an email he received regarding a need to repaint the curb at Spring Valley Lake Parkway and Country Club Drive.
- IV. Information/Non Action Items**
 - a. Update on Resolution on Long-Term Street Parking-** The Secretary provided a timeline and update on the County Ordinance that will incorporate the MAC's resolution, the Secretary also received direction to inform CHP. The ordinance will be considered by the Board of Supervisors for final adoption in January.
 - b. Ridgecrest Wall improvements discussion**
 - i. A resolution will be brought to the MAC in January for possible action-**
The Secretary provided an update on options that MAC can consider that have financial backing from the Supervisor's Office. Vice Chair Boyd provided information and a powerpoint on murals, as related to the wall. The item was discussed by the board. Chair Walters and Vice Chair Boys will draft a resolution for the MACs consideration.
 - c. Discussion priorities and future projects-** Chair Walters mentioned family day and the possibility of having CHP present, as well as other County organizations. Member Lawrence asked about the possibility of having a county code that redefines a gold cart as a 4 seater, for Spring Valley Lake.

 - b. Annual election of Chairperson and Vice Chairperson-** The Chair explained that at the January meeting the MAC will be holding elections for Chair and Vice Chair.
 - c. A resolution on Ridgecrest Wall Improvements will be brought to the MAC in January for possible action-** Reemphasized.
- VI. Supervisor's Office Report-** Provided an update from County Public Works related to County Code 83.11.100. Provided an update on Apple Valley's Bear Valley Rd Bridge Project. Provided an update on the archway removal and landscaping project. Provided information from County Public Works on the gap between the wall on Yates and the property owners yards/fences. Provided information from Public Works on the possibility of double yellow lines on Vista Point.
- VII. Council Member Comments-** The Secretary was asked to send the information on the Yates Wall Gap to SVLA Public Safety. Member Richman requested the Secretary inquire as to repainting the curb on Spring Valley Lake Parkway x Country Club Drive. He also

mentioned a state law prohibiting parking within 20 feet of a crosswalk, and asked about having no parking signs installed due to street sweepers effect on the painted red curb. Member Lawrence asked about the Chair interviewing with the SVLA General Manager and putting articles in the Breeze.
