- III. Public Comment-** One member of the public, identified as Danny, made comments on the archway and being willing to do a rendition for the MAC.

 - a. CSA 64 update on projects, verification of backup for Pebble Beach tank-** Well #8 was discussed, information on Pebble Beach tank was provided and board questions were answered. (item VII was discussed after V.a. to accommodate the CSA representatives)
 - b. Ridgecrest Wall-** Discussion on having the wall painted from Chinquapin to Pahute, with possible murals. Supervisor's office will look into it.
 - c. Vista Point Traffic light expedite project-** Discussion on the importance of a traffic signal at the intersection of Vista and Ridgecrest. Supervisor's office provided information on timeline and funding of the project. Board emphasized the need to move this along quickly due to safety concerns. Supervisor's office will look into it.
