Call to Order- 6:00pm (All members present, with the exception of Member Hardy)

- I. **Approval of the Agenda-** Motion to approve made by Member Lawrence, seconded by Member Richman; Vote was 3-0.
- II. **Approval of the Minutes of the April 15, 2025 Meeting-** Member Richman made the motion to approve. Seconded by Member Lawrence. Vote was 3-0.
- III. **Public Comment-** None.
- IV. **Community and Agency Reports-**
 - a. **San Bernardino County Sheriff-** Gave stats for Spring Valley Lake and answered MAC Member questions. Addressed traffic enforcement.

- V. **Chair Election-** Gar nominated Vice Chair Boyd. Seconded by Member Lawrence. Vote was 3-0.
- VI. **Possible Vice Chair Election (as needed)-** Member Lawrence nominated Member Hardy. Member Richman seconded the motion. Vote was 3-0.

- VII. **Spring Valley Lake Archway Removal and Landscaping Project-** The Secretary provided an update on the project and anticipated timeline. Secretary will follow up with Public Works.

Action Item

- VIII. **Ridgecrest Wall Improvements: Discussion and possible action on a proposed resolution on Ridgecrest Wall Improvements-** The Secretary provided an update on agreements with the HOA that would be needed for a mural. The MAC reviewed some renderings provided by the Secretary and directed the secretary to return with additional renderings per their direction. The MAC reached consensus on the colors of the paint be tan on the bottom, brown on top, with a wave separating the two colors, and the metal lettering should be a metallic, silver color. The secretary was directed to confirm what agreements with the HOA would be required for metal lettering.
- IX. **Supervisor's Office Report-** The Secretary provided an update on Fishing Hole 9, and was asked to follow up on utility/equipment boxes. The Secretary provided an update on the Vista Point traffic light, and the possibility of rumble strips on Vista Point.

X. Council Member Comments- Member Lawrence asked about view obstruction of bushes on Pahute and SVL Parkway, the secretary said he would look into it. Chair Boyd asked about condos going in on the Victorville side of Ridgecrest Road, the secretary said he would look into it.
